ISRAEL-HAMAS CEASEFIRE AGREEMENT

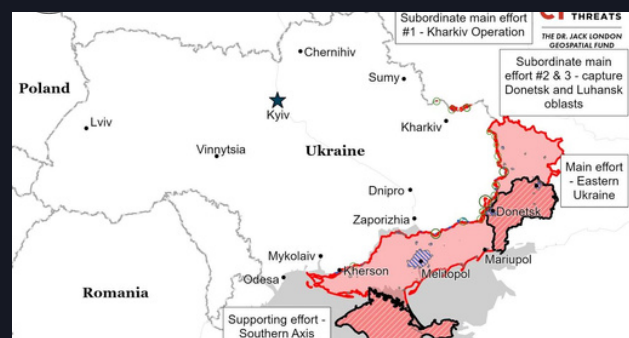
July 24, 2024

After several days of intense fighting, including rocket attacks from Gaza and retaliatory Israeli airstrikes, a ceasefire was mediated by Egypt, halting the violence. This agreement marks a critical pause in the conflict, which resulted in numerous casualties and significant destruction, and it opens a path for humanitarian aid to reach the affected areas in Gaza. The ceasefire's implications extend beyond the immediate region, affecting broader Middle Eastern peace and stability.

U.S. SUPREME COURT RULING ON ABORTION

The U.S. Supreme Court's decision to uphold the right to abortion, striking down several restrictive state laws, has ignited widespread national protests and celebrations. This ruling is a significant moment in the ongoing battle over reproductive rights in the United States, reflecting deep societal divisions. The outcome will have far-reaching political implications, influencing upcoming elections and shaping the national discourse on women's rights and healthcare.

UKRAINIAN COUNTEROFFENSIVE



July 5, 2024

Ukrainian forces launched a successful counteroffensive in the eastern Donbas region, reclaiming several towns from Russian-backed separatists. This military advance is a critical development in the ongoing conflict in Ukraine, signifying a strategic shift and boosting Ukraine's efforts to regain control over contested areas.



Middle East

July 6, 2024 - Lebanon Power Crisis

Lebanon faced a severe power crisis as fuel shortages led to widespread blackouts. The power cuts affected hospitals, businesses, and homes, exacerbating the country's ongoing economic and political crises. The Lebanese government appealed for international aid to address the fuel shortage and energy crisis.

July 9, 2024 - Saudi-Iran Diplomatic Talks

Saudi Arabia and Iran held high-level diplomatic talks in Baghdad, Iraq, aimed at reducing regional tensions and discussing mutual concerns such as the conflict in Yemen and maritime security in the Persian Gulf. The talks were seen as a significant step towards thawing relations between the two regional rivals, with the potential to impact broader Middle Eastern dynamics.



July 10, 2024 - Drone Attack on U.S. Base in Iraq

A U.S. military base in Erbil, Iraq, was targeted by a drone attack, believed to be carried out by Iranian-backed militias. The attack resulted in minor injuries and prompted a strong response from U.S. forces, who conducted airstrikes against militia positions.



July 13, 2024 - Syrian Peace Talks

Qatar hosted a new round of peace talks aimed at resolving the ongoing Syrian civil war. The talks involved representatives from the Syrian government, opposition groups, and major international stakeholders, including Russia, the United States, and Turkey. The focus was on implementing a nationwide ceasefire, prisoner exchanges, and humanitarian access to besieged areas. Although progress was limited, the talks were seen as a step forward in trying to bring an end to the conflict.



Middle East

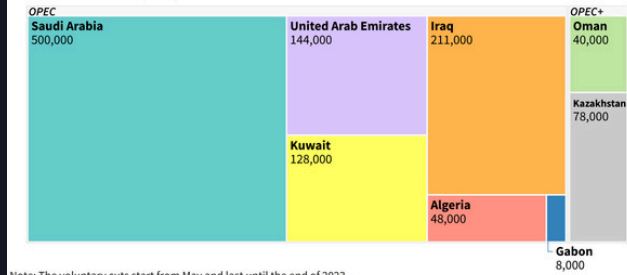
July 14, 2024 - Turkish Military Operation in Northern Iraq

Turkey launched a military operation targeting Kurdish militant positions in northern Iraq. The operation, named "Claw-Lock," aimed to eliminate threats from the Kurdistan Workers' Party (PKK), which Turkey considers a terrorist organization. The operation strained relations between Turkey and Iraq, raising regional security concerns.

Surprise production cuts

OPEC+ alliance on April 2 announced voluntary cuts to their production amounting to around 1.16 million barrels per day in a surprise move they said was aimed at supporting market stability.

Note: The voluntary cuts start from May and last until the end of 2023.

July 19, 2024 - Kuwait Energy Crisis and Oil Production Cuts

Kuwait announced a significant reduction in its oil production due to a technical malfunction at one of its major oil fields. The reduction amounted to nearly 20% of Kuwait's output, leading to concerns over its impact on global oil markets and the country's economy. This incident underscored the vulnerabilities of aging oil infrastructure in the Gulf and sparked discussions on the need for diversification.



July 28, 2024 - Oman Mediates Yemen Ceasefire

Oman successfully brokered a temporary ceasefire between the Yemeni government and Houthi rebels. The ceasefire aimed to allow humanitarian aid to reach civilians in conflict zones and was seen as a positive step towards resuming peace talks.



July 31, 2024 - Jordan Water Crisis

Jordan declared a state of emergency due to a severe water shortage affecting major cities and agricultural areas. The crisis, exacerbated by climate change and over-extraction, led to water rationing and increased tensions over water resource management. The government appealed for international assistance to address the growing water crisis.

Europe



JULY 8, 2024 - GREECE-TURKEY MARITIME DISPUTE

Greece and Turkey engaged in a tense standoff over maritime rights in the Eastern Mediterranean. Turkish survey ships entered contested waters, prompting a response from the Greek navy. The incident raised fears of a potential military confrontation, with both NATO and the EU urging restraint and dialogue to resolve the dispute.

UK-France Migrant Crisis Talks



July 10, 2024

UK and French officials held talks in Calais to address the ongoing migrant crisis in the English Channel. The discussions focused on measures to prevent dangerous crossings and enhance cooperation on immigration enforcement. The talks came amid a surge in migrant arrivals and heightened political tensions.

Spain - Catalonia



July 18, 2024

Tens of thousands of people gathered in Barcelona to demand Catalan independence from Spain. The rally was the largest since the failed independence referendum in 2017, reflecting ongoing separatist sentiments in the region. The Spanish government reiterated its opposition to Catalan independence but offered to resume talks.

France Protests Over Pension Reforms

July 19, 2024

Massive protests erupted across France in response to proposed pension reforms by President Emmanuel Macron's government. The reforms, aimed at increasing the retirement age, faced strong opposition from labor unions and the public.

Europe

**CYBERATTACK IN GERMANY**

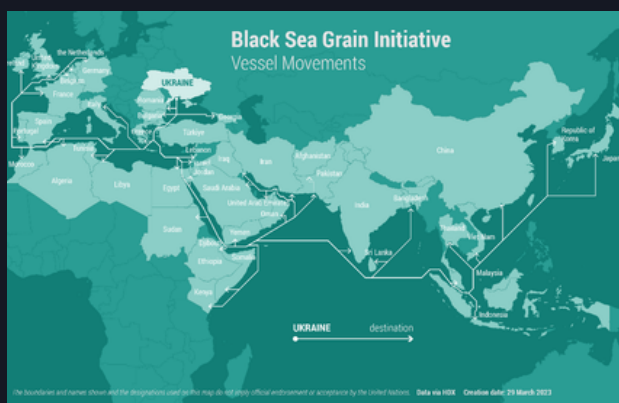
July 21, 2024

Germany experienced a large-scale cyberattack targeting government networks, believed to be orchestrated by a foreign state. The attack disrupted several government services and prompted a significant cybersecurity response. The incident raised concerns about the vulnerability of infrastructure to cyber threats.

Italian Banking Crisis

July 25, 2024

Italy faced a banking crisis as several major banks reported significant losses due to bad loans and market volatility. The crisis raised fears of a broader financial contagion in the Eurozone, prompting emergency measures by the European Central Bank.

Ukraine Black Sea Grain Agreement

July 27, 2024

Ukraine, Russia, and Turkey reached an agreement to allow the safe passage of Ukrainian grain exports through the Black Sea. The agreement aimed to ease global food shortages and stabilize grain prices, which had risen due to the ongoing conflict in Ukraine.

Poland Judicial Reform Protests

July 31, 2024

Tens of thousands of people protested in Warsaw and other Polish cities against proposed judicial reforms by the ruling Law and Justice Party. Critics argued that the reforms undermined judicial independence and democracy. The protests highlighted ongoing tensions between the Polish government and the European Union over rule of law issues.

Africa



LIBYA OIL PORT BLOCKADE

July 2, 2024

Armed groups in eastern Libya blockaded several key oil ports, demanding a share of oil revenues. The blockade disrupted Libya's oil exports, which are crucial to its economy. The incident highlighted the ongoing instability and factionalism in Libya, despite efforts to form a unified government.

South Africa Protests



July 6, 2024

Large-scale protests erupted in major South African cities, demanding government action against corruption and state capture. The protests were sparked by a series of corruption scandals involving high-level officials and public enterprises.

Coup Attempt in Sudan



July 7, 2024

An attempted coup by a faction of the Sudanese military was thwarted, leading to the arrest of several high-ranking officers. The coup attempt underscored the fragile political situation in Sudan following the 2021 military takeover and the ongoing transition to civilian rule.

Niger Terrorist Attack

July 15, 2024

A terrorist attack by Islamist militants in Niger's Tillabéri region resulted in the deaths of over 40 civilians. The attack highlighted the ongoing security challenges in the Sahel region, where extremist groups have intensified their operations.

Africa



DEMOCRATIC REPUBLIC OF CONGO (DRC) REBEL ATTACK

July 16, 2024

Rebel groups attacked several villages in the eastern DRC, leading to the deaths of dozens of civilians. The attacks were part of ongoing conflicts involving various armed groups in the region, which have caused significant humanitarian and security challenges.

Mozambique Insurgent Attack



July 19, 2024

Islamist insurgents launched a coordinated attack on a town in Mozambique's Cabo Delgado province, killing dozens of civilians and displacing thousands. The attack was part of an ongoing insurgency in the region, where extremist groups have exploited poverty and grievances to recruit fighters.

Ethiopia-Sudan Clashes



July 22, 2024

Renewed clashes between Ethiopian and Sudanese forces occurred along the disputed Al-Fashaga border region. Both countries accused each other of violating territorial sovereignty, raising concerns of a wider conflict.

Kenya Drought Crisis

July 30, 2024

Kenya faced a severe drought, affecting millions of people and threatening food security. The drought led to crop failures, water shortages, and increased tensions over scarce resources. The Kenyan government and humanitarian organizations launched emergency relief efforts, but the scale of the crisis required significant international assistance.



Asia

July 2, 2024 - Hong Kong Legislative Council Protest

Thousands of pro-democracy protesters gathered outside Hong Kong's Legislative Council building to oppose a new law that would increase government oversight over digital communications. The law was perceived as another move by Beijing to tighten control over Hong Kong's freedoms. Police used tear gas to disperse the crowd, leading to clashes and multiple arrests.

July 9, 2024 - Taliban-U.S. Talks in Qatar

Representatives from the Taliban and the United States met in Doha, Qatar, for high-level talks. The discussions focused on the humanitarian crisis in Afghanistan, counter-terrorism efforts, and the release of frozen Afghan assets. The talks underscored the ongoing complexities of U.S.-Taliban relations post-U.S. withdrawal.



July 11, 2024 - South China Sea Tensions

A U.S. Navy destroyer, the USS Benfold, conducted a freedom of navigation operation near the Spratly Islands, challenging China's extensive maritime claims.

This led to a diplomatic protest from Beijing, accusing the U.S. of "provocation" and "illegal intrusion."



July 15, 2024 - Myanmar Military Airstrikes

The Myanmar military conducted airstrikes against ethnic armed groups in the northern regions, resulting in numerous casualties and displacing thousands of civilians.

The airstrikes marked an escalation in the ongoing civil conflict following the military coup in 2021.

The international community condemned the violence, calling for a ceasefire and renewed dialogue.



Asia

July 18, 2024 - Japan-South Korea Trade Agreement

Japan and South Korea signed a new trade agreement aimed at strengthening economic ties and resolving previous trade disputes over export controls. The agreement marked a significant improvement in bilateral relations, which had been strained over historical and trade issues.

July 25, 2024 - Assassination of Philippine Mayor

The mayor of a key city in Mindanao, Philippines, was assassinated in what is believed to be an act of political violence.

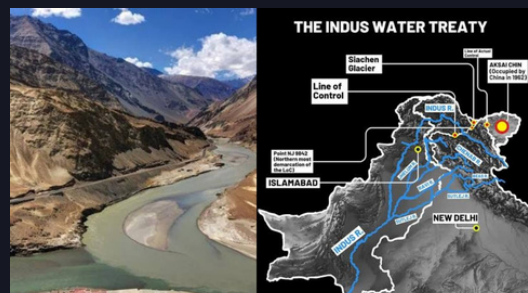
The assassination sparked concerns about security and governance in the region, which has a history of insurgency and clan rivalries.

America

July 1, 2024 - U.S. Supreme Court Ruling on Abortion

America

July 14, 2024 - Assassination of Brazilian Judge

A prominent anti-corruption judge in Brazil, known for his role in the "Operation Car Wash" investigation, was assassinated in São Paulo.

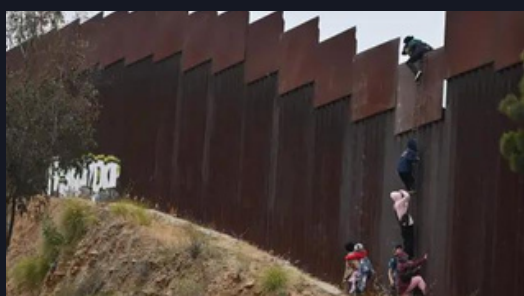
The assassination raised concerns about judicial independence and the safety of officials involved in high-profile corruption cases.

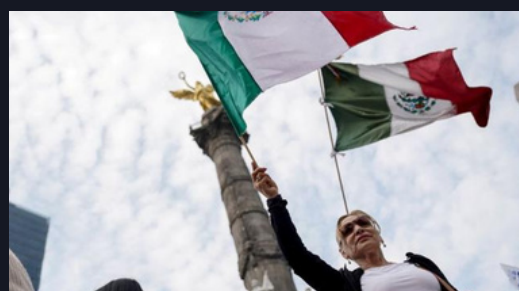


July 28, 2024 - Mexico-U.S. Border Incident
